all that piece, parcel or lot of land in Chick Springs

Township, Greenville

County, State of South Carolina , to-wit:

All those pieces, parcels or tracts of land, situate, lying and being in Chicks prings Township, Greenville County, and containing approximately twenty-three (23) acres, according to a survey made by W.A. Hester, Engineer, Hovember 14, 1911, and a later survey made by W.S. Riddle, Engineer, in September 1918; and having the following metes and bounds, to-wit:

Beginning at a stake on branch at corner of lands now or formerly of R. Sammons, and running thence down the branch following the meanderings thereof in a general northerly direction to a stake on the Southwest bank of the Inoree River; thence N.11.-30 W. 995.28 feet, crodsing Enoree River to a stake on the Northwest Bank of said River; thence S.73 W. 265.98 feet, crossing said River to a stake at corner of lands now or formerly of Sammons; thence with said Sammons line S.19W. 1420.92 feet to a stake; thence S. 71-20 E. 188 feet to a stake at the beginning of a gully; thence S. 76-15 E. 388 feet along gully to a pine tree; thence S. 7 W. 400 feet to a stake; thence S. 9 W. 335 feet to the stake at the beginning corner.

Also: All that piece, parcel or lot of land on the West side of Enoree River, lying between said River and the lands above described and being the same land conveyed to H.A. Taylor by two deeds, one from Pauline Pickens and one from Harry Greer, containing one (1) acre, one rod and two square perches, more or less.

These are the same lots of land conveyed to Katherine Batson Bridwell by Elmira Lofti, Manly Loftis, Eunice Loftis Jaimison, Inice Loftis, Ralph L ftis, Theron Loftis, and Willie L. Styles by deed nated October 3rd 1942, said deed being recorded in the office of the Register of Mesne Conveyance for Greenville County, in Deed Book 248, at Page 11.
