All that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in Austin Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 6 of B. F. Reeves Subdivision in accordance with plat made by H. S. Brockman, dated September 14, 1958 and to be recorded in the R. M. C. Office for Greenville County, and being more fully described according to said plat, to-wit:
