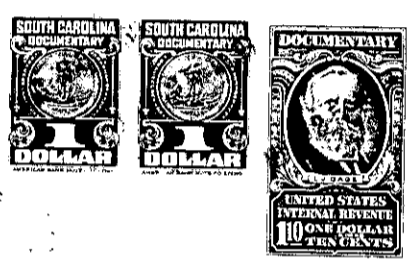
OLLIE Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gordon Lee Frazier and Edith D. Frazier, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, on the northeastern corner of the intersection of S. C. State Highway No. 183 and Hope Street and being known and designated as Lot No. 9 on property of grantor recorded in the R. M. C. Office for Greenville County in Plat Book "OO", at Pages 66 and 67 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern corner of the intersection of S. C. State Highway No. 183 and Hope Street and running thence along said Hope Street S. 38-30 E. 192.5 feet to an iron pin; thence along a 15-foot alley N. 51-50 E. 100 feet to an iron pin; thence along the joint line of Lots Nos. 8 and 9 N. 38-30 W. 192.5 feet to an iron pin; thence along the southeastern side of State Highway No. 183 S. 51-50 W. 100 feet to the point of beginning.
