LONG and EDITH H. LONG, their heirs and assigns,

ALL That certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in the County of Greenville, State of South Carolina, near the City of Greenville, being known and designated as Lot No. 197, according to plat of Belle Meade (Section 1 & 2), made by Piedmont Engineering Service in June, 1954, recorded in the Office of the R.M.C. for Greenville County in Plat Book EE, Pages 116-117, (and being more particularly shown on plat of property of Carol H. Long & Edith H. Long, dated Dec. 11, 1958, prepared by C. C. Jones, Engineer) and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the northern side of Camden Lane at the joint front corner of Lots 197 and 198 and running thence along the common line of said lots, N. 9-49 E. 141.4 feet to an iron pin in the rear line of Lot 51; thence along the rear line of Lots 51 and 52, N. 69-59 W. 103.7 feet to an iron pin; thence S. 61-42 W. 20.5 feet to an iron pin in rear line of Lot 53; thence turning and running along the line of Lot No. 196, S. 5-35 E. 171.5 feet to an iron pin on the northern side of Camden Lane; thence along the northern side of Camden Lane, N. 85-50 E. 75 feet to an iron pin, the point of beginning.
