All that piece, parcel or lot of land in Greenville County, South Carolina, on the South side of Wilbanks Street, being known and designated as Lot No. 9 on a map of West Boulevard, property of I. Saul, made by R. E. Dalton, Engineer, in August 1924, recorded in the R. M. C. Office for said County and State in Plat Book "F" at page 246, and, according to said plat, being described as follows:
