All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 216 of Addition No. 1 of South Forest Estates recorded in plat book EE page 195 of the RMC Office for Greenville County, S.C. and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the north side of Plainfield Circle, the front joint corner of Lots Nos. 215 and 216; thence with the joint line of said lots N. 38-17 W. 197.6 feet to an iron pin in line of Woodfields subdivision; thence with the line of said subdivision N. 49-45 E. 118.3 feet to an iron pin; thence N. 43-24 W. 26.6 feet to an iron pin; thence N. 48-46 E. 80 feet to an iron pin corner of Lot No. 217; thence with the line of said lot S. 9-47 E. 275.6 feet to an iron pin on the north side of Plainfield Circle; thence with the north side of said Street S. 60-51 W. 65 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

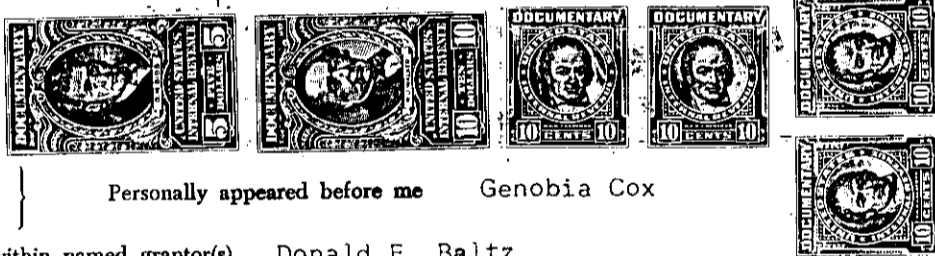
