



(. Know All Men by these Presents:

J. R. WHITMIRE in the State aforesaid, in consideration of the sum of Nineteen Thousand and No/100 ----(\$19,000.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release. unto the said J. Earle Watkins, his Heirs and Assigns, forever:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot 35 on a plat of Morningside recorded in Plat Book EE, Pages 2 and 3 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Estanolle Street at the joint front corner of Lots 35 and 51 and running thence with the line of Lot 51 N. 34-25 W. 167 feet to an iron pin at corner of Lot 34; thence with the line of Lot 34 S. 62-22 W. 192.5 feet to pin on Richbourg Road; thence with the eastern side of Richbourg Road S. 32-11 E. 143.7 feet to pin; thence with the curve of the intersection of Richbourg Road and Estanolle Street, the chord of which is S. 79-51 E. 39.1 feet to pin on Estanolle Street; thence with the northern side of said street N. 61-32 E. 170.9 feet to the point of beginning.



Being the same premises conveyed to the grantor by deed recorded in Deed Book 555, Page 87.

It is understood and agreed that this conveyance is made subject to restrictive covenants recorded in Deed Book 470, Page 369, applicable to all lots in said subdivision and also those shown on the recorded plat.
