All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 45 of Indian Hills, plat of which is recorded in the R.M.C. Office in Plat Book 60, Page 11, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Hunts Bridge Road, joint front corner of Lots Nos. 44 and 45, and running thence with the line of said lots, N. 32-35 E., 130 feet; thence N. 13-10 W., 123.5 feet to an iron pin on Hiwassee Drive; thence with Hiwassee Drive, S. 31-40 W., 168.2 feet to intersection of Hiwassee Drive with Hunts Bridge Road; thence with curve, the chord of which is S. 37-07 W., 28.5 feet; thence with Hunts Bridge Road, S. 7-25 E., 100 feet to the point of beginning.
