Teasley, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the northerly side of Fleetwood Drive, near the City of Greenville, S. C., being shown as Lot No. 30 on the plat of Magnolia Acres as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Fleetwood Drive at a point 346 feet east of the northeasterly corner of the intersection of Fleetwood Drive and Cool Brook Drive, said pin being the joint front corner of Lots 29 and 30, and running thence along the joint line of said lots N 25-49 W 175 feet to an iron pin; thence N 64-11 E 85 feet to an iron pin, joint rear corner of Lots 30 and 31; thence along the joint line of said lots S 25-49 E 175 feet to an iron pin on the northerly side of Fleetwood Drive; thence along the northerly side of said Drive S 64-11 W 85 feet to the point of beginning.
