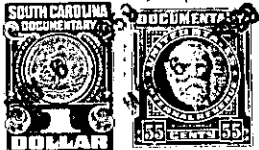

H. Price and Larry G. Shaw, their heirs and assigns:

All that piece, parcel or lot of land situate, lying, and being in the County of Greenville, State of South Carolina, and being known and designated as lot #43, part of Thornwood Acres, property of Williams Land Company, Inc., according to plat by Jones & Sutherland, Engineers, dated December 1958, plat of which is recorded in the R.
