to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

PAUL E. RUFF, his heirs and assigns forever,

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina in Greenville Township, being known and designated as LOT NO. 15 on Birchwood Drive according to a plat of the Subdivision known as KIRKWOOD HEIGHTS made by Pickell & Pickell, Engrs., October 1954 and recorded in the RMC Office for Greenville County in Plat Book EE, at pages 110 and 111 and having the following metes and bounds, to wit:

BEGINNING AT AN IRON Pin at the joint front corner of Lots 14 and 15 and running thence along the joint line of said lots, South 49-18 East 150 feet to an iron pin; running thence South 40-42 West 78 feet to an iron pin at joint rear corner of Lots 15 and 16; running thence along the joint line of said lots, North 49-18 West 150 feet to an iron pin on Birchwood Drive; running thence along Birchwood Drive, North 40-42 East 78 feet to an iron pin, the beginning corner.

This property is sold subject to the restrictive covenants pertaining to said subdivision and to all easements, rights of way and reservations recorded against said subdivision and to the building line and restrictions as shown on said plat referred to herein. Said Restrictive Covenants being recorded in the RMC Office for Greenville County in Deed Book 519, at page 439.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

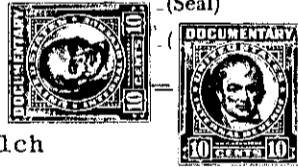
