CHAPMAN and VIRGINIA M. CHAPMAN, Their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 38 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of McSwain Drive at the joint front corner of Lots 37 and 38 and running thence S 64-19 W 130 feet to a point at the joint rear corner of Lots 37 and 38; thence N 25-41 W 99.8 feet to a point at the joint rear corner of Lots 38 and 39; thence N 64-19 E 135.8 feet to a point on the Southwestern side of McSwain Drive at the joint front corner of Lots 38 and 39; thence with the Southwestern side of McSwain Drive S 22-23 E 100 feet to the point of beginning.
