

6. In the event the works of improvement herein described are not installed on said land within 72 months from the date hereof, the rights, privileges, and authority granted herein to the Local Organization shall be terminated.

7. Special Provisions:

The Landowner agrees not to use, graze, or permit cutting of grass on or within the area of the dam (or other improvements) enclosed by wire fence except upon written permission of and upon the terms specified by the authorized representative of the Sponsoring Local Organization.

The Landowner agrees not to place any screen or other obstruction around the outlets installed in the dam or to change the water level established by the Local Organization.

The Local Organization shall have the right to trim or remove such underbrush or vegetable life including trees from the above described land as interfere with the construction, maintenance, or operation of said floodwater retarding structure located on the lands of others. Provided, however, all merchantable timber which may be cut by virtue of the provision of this paragraph shall be and remain the property of the Landowner, and the Local Organization shall place such timber in an orderly manner upon the lands of the Landowner adjacent to said reservoir.
