"ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the North side of Falmetto Avenue, and being known and designated as Lot No. 18 of Block "D" on a plat of Riverside, recorded in the R.M.C. Office for Greenville County in Flat Book "A", pages 322-323, and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the North side of Falmetto Avenue, joint corner of Lots Nos. 17 and 18, and running thence with line of Lot No. 17 North 10-15 East 125 feet to an iron pin on a fifteen foot alley; thence with the South side of said alley South 79-45 East 50 feet to an iron pin, joint corner of lots Nos. 18 and 19; thence with line of Lot No. 19 South 10-15 West 125 feet to an iron pin on the North side of Falmetto Avenue; thence with Falmetto Avenue North 79-45 West 50 feet to an ironpin, the BEGINNING corner; being the same land conveyed to S.
