signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is FIDELITY HOMEOWNERS CLUBS, INC.

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to engage in the business of selling systems franchises to persons who will furnish services to homeowners and others, consisting of procuring proper suppliers of labor and/or materials, to perform requested repairs, maintenance, alterations and additions for the benefit of such homeowners and others at their expense; to assist such franchise dealers in the establishment and the operation of their respective businesses; and to do all other things incidental to the carrying on of such business.

FIFTH: That the amount of the capital stock is Eighteen Thousand (\$18,000.00)----- Dollars payable in cash or equivalent at the call of the Directors.

a newspaper published in the County of Greenville

NOW, THEREFORE, I, O.
