

All that piece, parcel or lot of land lying and being in the County of Green-ville, State of South Carolina, being known and designated as Lot No. 48, Block D, according to a plat of the property of Mrs. Corinne Bates, plat made by Piedmont Engineering Service, January, 1949, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book Y, page 53, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at the intersection of the eastern side of Batesview Drive with the southern side of Carmel Street and running thence along the southern side of Carmel Street in an easterly direction 234.3 feet to an iron pin; thence in a southerly direction 100 feet to an iron pin at the rear corner of Lot No.49 thence along the northern line of lot no. 49 in a southwesterly direction to an iron pin on the eastern side of Batesview Drive; thence along the eastern side of Batesview Drive, N. 33-35 W. 100 feet to an iron pin at the point of beginning.

Any construction on the lot shall be set back a distance of 50 feet from the front line.
