

presents do grant, bargain, sell and release unto the said . MARIE D. MEETZE her heirs and assigns forever: . ALL that lot of land, with the buildings and improvements thereon

situate on the East side of Keith Drive in the City of Greenville; S. C. being shown as property of "Hammett" on a plat made by C. C. Jones & Associates, April 6, 1956, recorded in the RMC Office for Greenville County S. C. in Plat Book LL, page 7; and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin in the center of Keith Drive at corner of property of Ed B. Smith and rums thence along the Smith line N. 61-18 E. 188.8 feet to an iron pin; thence continuing with Smith line N. 61-18 E. 55.1 feet to an iron pin; thence S. 38-50 E., 219 feet to an iron pin; thence S. 51-10 W. 75 feet to an iron pin at corner of Ridenhour property; thence with the Ridenhour property line N. 55-09 W. 80.7 feet to an iron pin; thence still with the Ridenhour line S. 79-55 W. 75:1 feet to an iron pin; thence still with the Ridenhour line S. 67-32 W., 158.6 feet more or less to a point in the center of Keith Drive; thence with the center of Keith Drive N. 18-43 W. 37.1 feet to an iron pin; thence still with the center of Keith Drive N. 7-18 W. 90 feet to the beginning corner.

Grantee assumes and agrees to pay the balance due on that mortgage given by Byrd Lucius Hammett and Charles Manley Hammett to Fidelity Federal Savings and Loan Association of Greenville, S.
