ALL that certain tract of land in Chick Springs Township, Greenville County, South Carolina, near Paris, having the following metes and bounds according to a plat entitled "Property of Calvin C. Moore", prepared by C. C. Jones on December 9,

BEGINNING at an iron pin on the West side of Green Street, and running thence along the line of property now or formerly owned by E. H. Greene S 26-20 W 424 feet to an iron pin; thence N 63-40 W 249.4 feet to an iron pin; thence N 26-16 E 276.2 feet to an iron pin; thence N 85-45 E 142.2 feet to an iron pin; thence continuing in the same direction N 85-45 E 149.3 feet to the beginning corner and containing 2.02 acres, more or less.

This deed is made subject to an easement for a 12 foot right of way for purposes of ingress and egress to other adjacent property and is parallel and adjacent to the E.H. Greene property as shown on said plat and in accordance with the reference to said easement as shown in deed of E. Inman, Master to Ida Bertha Moore as of record in Vol. 239, page 38.
