Know All Men by These Presents:

That I, M. W. Fore in consideration of the sum of One Thousand & NO/100 (\$1,000.00) - - - - - in the State aforesaid, - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Annie M. Gudger, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lots Nos. 82 and 83 of a subdivision known as Bel Aire Estates, as shown on a Plat thereof, dated May 1956, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 19, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Pocahatchie Trail joint front corners of Lots Nos. 81 and 82 and running thence along the line of said lots, S. 85-30 W. 170 feet to iron pin rear corner of Lots Nos. 73 and 74; thence running with rear line of Lots 73 and 72, S. 4-30 E. 140 feet to iron pin rear corner of Lot 84; thence running with line of said lot, N. 85-30 E. 170 feet to iron pin on Pocahatchie Trail; thence running with said Trail N. 4-30 W. 140 feet to iron pin at point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay 1959 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
