Harding, his heirs and assigns: All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, shown as Lot No. 5 on plat of Western Hills, Section 2, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book KK, Page 130, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on El Paso Drive at joint front corner of Lots Nos. 5 and 6, and running thence with the line of said lots N. 50-17 E., 180.7 feet; thence S. 35-23 E., 170.4 feet to an iron pin on El Paso Drive; thence with El Paso Drive S. 77-39 W., 139.4 feet to curve; thence with curve the chord of which is N. 71-02 W., 68.3 feet; thence continuing with El Paso Drive N. 39-43 W., 60 feet to the point of beginning.
