to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Maude W. Collins, her heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the easterly side of Whitman Drive, near the Town of Taylors, S. C., being shown as Lot No. 44 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Whitman Drive at a point 175 feet south of the southeasterly corner of the intersection of said Drive with East Heathwood Drive, said pin being the joint corner of Lots 43 and 44, and running thence with the line of Lots 43 and 42 S 80-06 E 200 feet to an iron pin, joint rear corner of Lots 42 and 44; thence with the line of Lot 39 S 9-54 W 100 feet to an iron pin, joint rear corner of Lots 44 and 45; thence with the joint line of said lots N 80-06 W 200 feet to an iron pin on the easterly side of Whitman Drive; thence with the easterly side of said Drive N 9-54 E 100 feet to the point of beginning.
