

Aiken, in the State aforesaid, in consideration of the sum of Three Thousand Four Hundred Forty-eight & 27/100 (\$3,448.27) and the assumption of the mortgage hereinafter referred to, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(x) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Fred E. Aiken, his heirs and assigns

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville at the southeastern corner of Longview Terrace and East Faris Road in the City of Greenville being shown as Lot 34 on a plat of Forest Heights, recorded in Plat Book P at page 71 and described according to a more recent survey prepared by J. C. Hill as follows:

BEGINNING at a stake at the southeastern corner of East Faris Road and Longview Terrace and running thence with the east side of East Faris Road as follows: S. 23-05 W. 50 feet; S. 15-25 W. 50 feet; and S. 7-09 W. 60 feet to a stake on a alley; thence with the northern side of said alley, S. 86-50 E. 100 feet to an iron pin at corner of Lot 35; thence with the line of said lot, N. 26-55 E. 140 feet to a stake on Longview Terrace; thence with the southern side of Longview Terrace, N. 53-05 W. 100 feet to a stake; thence with the curve of the intersection of Longview Terrace with East Faris Road, the cord of which is S. 71-55 W. 35.5 feet to the beginning corner.

This is the same property conveyed to the grantors herein by deed of Blanche C. Acree by deed dated August 1, 1958 and recorded on August 11, 1958 in the office of the R.M.C. in Deed Book 603 at page 550.

As part of the consideration for this conveyance the grantee assumes and agrees to pay that certain mortgage executed by Blanche C. Acree to Fidelity Federal Savings & Loan Association, February 22, 1955 and recorded in the Office of the R.M.C. in R.E.M. Book 630 at page 471 on which there is an outstanding balance of \$12,551.73.
