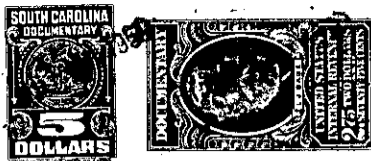

acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
the said

W. LEWIS STOVER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South
Carolina, near the City of Greenville, and being known and designated as Lot Number 104 of a
subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for
Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of McSwain Drive at the joint front corner of Lots 103 and
104 and running thence N 64-19 E 175 feet to a point at the joint rear corner of Lots 103 and 104; thence
S 22-23 E 128 feet to a point on the Northern side of Mimosa Drive at the joint corner of Lots 104 and
105; thence with the Northern side of Mimosa Drive S 56-52 W 55.8 feet to a point; thence continuing
with the Northern side of Mimosa Drive S 54-55 W 98.4 feet to a point; thence following the curvature
of the Northeastern intersection of Mimosa Drive with McSwain Drive (the chord of which is N 73-34 W
31.1 feet) to a concrete monument; thence with the Eastern side of McSwain Drive N 22-23 W 140.8
feet to the point of beginning.

Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully
claiming or to claim the same or any part thereof.
