Levis L. Gilstrap and Lloyd W. Gilstrap, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Haynsworth Road and being known and designated as Lot No. 6 of Haynsworth Heights as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "V", at Page 65 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Haynsworth Road at the joint front corner of Lots Nos. 5 and 6 and running thence along said Road N. 25-20 W. 71.5 feet to an iron pin; thence along the joint line of Lots Nos. 6 and 7 N. 48-40 E. 300 feet to an iron pin; thence S. 44-12 E. 69.5 feet to an iron pin; thence along the joint line of Lots Nos. 5 and 6 S. 48-40 W. 324 feet to the point of beginning. Haynsworth Road is also known as Edgemont Avenue.
