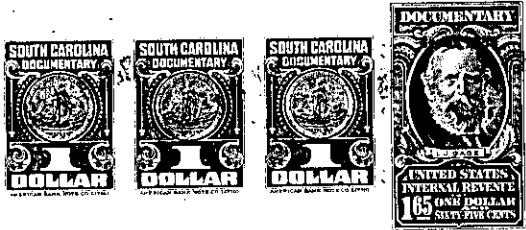
That We, P. L. Bruce, T. S. Bruce and Nora B. Bruce,

BEGINNING At an iron pin on the southern side of Perry Road at the joint front corner of Lots 15 and 16 and running thence along the joint line of said lots, S. 10-05 E. 149.6 feet to an iron pin in the rear line of Lot 21; thence along the rear line of said lot, N. 86-0 E. 80.45 feet to an iron pin, joint rear corner of Lots 21 and 22, 14 and 15; thence along the joint line of Lots 14 and 15, N. 10-05 W. 158.1 feet to an iron pin on the southern side of Perry Road, joint front corner of Lots 14 and 15; thence along the southern side of Perry Road, S. 79-55 W. 80 feet to the point of beginning.
