ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the Northern side of Miracle Drive, in Gantt Township, County of Greenville, State of South Carolina, shown and designated as Lot No. 141 on Plat No. 2, Section No. 1, of Fresh Meadow Farms according to the plat made by R. K. Campbell, Surveyor, revised May 18, 1957, recorded in the R.M.C. Office of Greenville County, South Carolina, in Plat Book "NN" at page 85, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING AT an iron pin located on the Northern side of Miracle Drive, being the joint corner of Lots 140 and 141, and running thence N. 67-15 W. 80.4 feet along the Northern side of Miracle Drive to an iron pin, being the joint front corner of Lots 141 and 142; thence running N. 41-23 E. 176.8 feet along the line of Lot 142 to an iron pin, being the joint rear corner of Lots 139, 141, 142 and an area designated as "playground"; thence running S. 57-15 E. 60 feet along the line of Lot 139 to an iron pin, being the joint rear corner of Lots 140 and 141; thence running S. 35-38 W. 162.6 feet along the line of Lot 140 to an iron pin located on the Northern side of Miracle Drive, being the joint corner of Lots 140 and 141, the point of beginning.
