

KNOW ALL MEN BY THESE PRESENTS:

That I, Robert Albert Kummerer, a legal resident of the City (Town) of Tiffin, County of Seneca, State of Ohio, United States of America, now in the military service as a TSgt, Serial Number AF15281339 in the Air Force of the United States, and at present being stationed in said military service at Donaldson Air Force Base, S. C. have made, constituted and appointed and by these presents do make, constitute and appoint my wife, Katheryn L. Kummerer whose address is 509 Churchill Circle, Greenville, S. C., my true and lawful attorney to act in, manage, conduct, concur with persons jointly interested with myself therein, and do all or any of the following acts, deeds, and things, that is to say: To perform any act or deed or sign any papers necessary to accomplish the purchase of the house and lot located at 509 Churchill Circle, Greenville, S. C., now owned by Clyde Dorr. I intend this power to include all acts and deeds and the signing of all papers necessary in obtaining an F. H. A. loan of the purchase price of the above described property.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, matter, and thing whatsoever in the premises, as fully and effectively to all intents and purposes as I might or could do in my own proper person if personally present; and hereby ratify all that my said attorney shall lawfully do or cause to be done by virtue of these presents.

And I hereby declare that any act or thing lawfully done hereunder by my said attorney shall be binding on myself, and my heirs, legal and personal representatives and assigns; whether the same shall have been done before or after my death or other revocation of this instrument, unless and until reliable intelligence or notice thereof shall have been received by my said attorney; and whether or not I, the grantor of this instrument, shall have been reported or listed, either officially or otherwise, as "missing" or "missing in action" as those words are used in military parlance, it being the intent hereof that such status designation shall not bar my attorney from fully and completely exercising and continuing to exercise any and all powers and rights herein granted, and that such report of "missing" or "missing in action" shall neither constitute nor be interpreted as constituting notice of my death nor operate to revoke this instrument.
