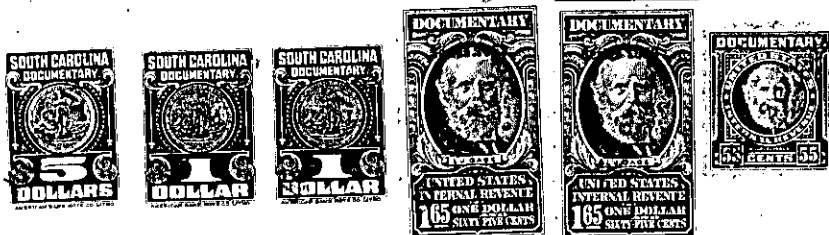
Know All Men by These Presents:

H. Trammell, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book B, Page 47, and according to said plat, having the following metes and bounds, to-wit:
