That I, WILLIAM R. TIMMONS, JR., in the State aforesaid, in consideration of the sum of One Thousand Nine Hundred Forty-Five and No/100--(\$1,945.00)--- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. FRANK DURHAM, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 36 of a sub-division known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Mimosa Drive at the joint corner of Lots 36 and 37 and running thence N 26-20 W 163.3 feet to a point at the joint rear corner of Lots 36 and 37; thence S 64-19 W 119 feet to a point on the Northeastern side of Astor Street at the joint corner of Lots 35 and 36; thence with the Northeastern side of Astor Street S 25-41 E 163.4 feet to a point; thence following the curvature of the Northeastern intersection of Astor Street with Mimosa Drive (the chord of which is S 80-30 E 26.4 feet) to a point; thence with the Northwestern side of Mimosa Drive N 55-04 E 97.5 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1959 taxes.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
