to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Arlie L. Tinsley, his heirs and assigns

All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, being on the west side of the Old Easley Bridge Road and being shown and designated as Lots Nos. 32 and 33 on plat of "PLAINVIEW HEIGHTS" recorded or to be recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ, Page 23, and being more recently shown on survey of said lots completed by Jones and Sutherland, Engineers, on June, 1959, said lots having the following metes and bounds, to-wit:

Beginning at an iron pin on the southwest side of Jerome Drive, joint front corners of Lots Nos. 30 and 32, and running thence N. 54-55 W. with the southwest side of Jerome Drive 54.2 feet to an iron pin; thence N. 52-54 W. with the southwest side of Jerome Drive 49.7 feet to an iron pin, joint front corners of Lots Nos. 32 and 33; thence N. 52-54 W. with the southwest side of Jerome Drive 100 feet to an iron pin; thence S. 86-46 W. 33.9 feet to an iron pin on the south side of Plainview Drive; thence S. 57-34 W. 120 feet to an iron pin on the south side of Plainview Drive, joint front corners of Lots Nos. 33 and 34; thence S. 30-03 E. 170 feet to an iron pin, joint rear corners of Lots Nos. 32 and 33; thence S. 10-20 E. along the rear lines of Lots Nos. 35 and 36, 146.2 feet to an iron pin on the rear line of Lot No. 36; thence N. 68-30 E. 62 feet to an iron pin, joint rear corners of Lots Nos. 28 and 29; thence with the rear line of Lot No. 29 N. 34-42 E. 93.6 feet to an iron pin, joint rear corners of Lots Nos. 29 and 30; thence with the rear line of Lot No. 30 N. 33-30 E. 158.4 feet, joint front corners of Lots Nos. 30 and 32, the point of beginning.

The property herein conveyed is subject to the restrictions applicable thereto recorded in the RMC Office for Greenville County in Deed Book 610, Page 311, and subject to setback lines as shown on plat of June, 1959, hereinabove referred to and further subject to utility easements and rights of way of record.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

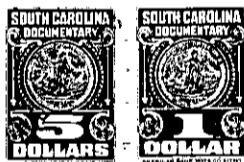
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

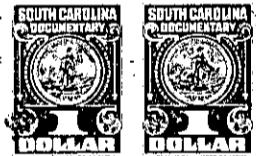
