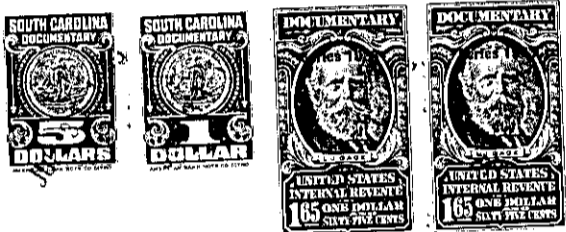
That I, W. H. Meadors, in the State aforesaid,
