Silvers, her heirs and assigns forever; an undivided one-half interest in:

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being about five (5) miles Northwest of Travelers Rest on the Eastern side of Keeler Mill Road in Greenville County, State of South Carolina, and having the following metes and bounds, to-wit:

BEGINNING AT an iron pin on the Eastern side of Keeler Mill Road at the joint corner of the property hereby being conveyed and property of William Stone, and running thence S. 53-00 E. 398 feet to an iron pin; being the joint corner of property of M.
