All that lot of land in Greenville County, state of South Carolina in Bates Township, in the town of travelers Rest, being shown as all of lot 6, and a... small triangular section taken from 10% 7, as shown on plat of property of J.H. Roe, et al, recorded in plat book "G at page 234, and being more particularly described as follows:

Beginning at an iron pin on the southwest corner of the intersection of McAlhaneystreet, and main street, and running thence with the western side of main street, N. 29-05 W. 20.5 feet to the pin at corner lot 5, S 61-35 W. 60 feet to Ironpin in line of lot 7; thence through lot 7, in a southerly direction 75 ft. more or less, to pin on McAlhaney street, which pin is 6 feet in a southwesterly direction from the joint front corner of lots 6 and 7, thence with the northwest side of McAlhaney Street, 58.2 feet to the point of beginning.

ALSO, an easement in and to the wall extending along the divideing line of lots 6 & 5 with the right to the grantees, his heirs and assigns, to use said wall as now constructed.
