Know All Men by These Presents:

That I, William L. Costner, in consideration of the sum of Seven Thousand Three Hundred Fifty Nine and 63/100-- DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged); have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Cliff H. Stevens, Jr. and Veraldean W. Stevens, their Heirs and Assigns forever:

All that piece, parcel or lot of land, situate, lying and being in Gantt Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 243 of Belle Meade, Section 3, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Page 187 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Pine Creek Drive at the joint front corner of Lots Nos. 242 and 243, and running thence along the joint line of said Lots, N. 57-52 W. 135 feet to an iron pin; thence N. 32-08 E. 80 feet to an iron pin; thence along the joint line of Lots Nos. 244 and 243, S. 57-52 E. 135 feet to an iron pin; thence along the northwestern side of Pine Creek Drive, S. 32-08 W. 80 feet to the point of beginning.

The above is the same property conveyed to the grantor by Derby Heights, Inc. by its deed dated May 18, 1959 and recorded in Deed Book 625, at Page 270.

As part of the consideration of this conveyance the grantees assume and agree to pay the balance due on the mortgage given by the grantor to Fidelity Federal Savings and Loan Association and recorded in the R. M. C. Office for Greenville County in Mortgage Book 788, at Page 39, the balance now due and owing being \$11,840.37.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
