to it in hand duly paid at and before the sealing and delivery of these presents by the grantee (hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **RICHARD ARNOLD:**

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 24 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in January, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, (as amended) the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Vicki Circle, the joint front corner of Lot No. 23 and 24 and running thence along the curve of Vicki Circle on its Northeastern side S. 52-05 E. 80 feet to an iron pin on Vicki Circle; thence turning and running N. 49-05 E. 288.9 feet; thence N. 21-21 W. 53 feet to an iron pin; thence N. 85-29 W. 160 feet to an iron pin; thence S. 27-10 W. 225.5 feet to an iron pin on Vicki Circle, the point of beginning.
