to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Hubert E. Thomas, his Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, on the northern side of Midway Road and being known and designated as Lot No. 29 of Pecan Terrace, Section 2, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "EE", at Page 108 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Midway Road at the joint front corner of Lots Nos. 29 and 30 and running thence along the joint line of said Lots, N. 3-05 W. 169.8 feet to an iron pin; thence N. 87-33 E. 80.4 feet to an iron pin; thence along the joint line of Lots Nos. 28 and 29, S. 3-05 E. 169 feet to an iron pin; thence along the northern side of Midway Road, S. 86-55 W. 80 feet to the point of beginning.

The above property was owned by A. C. Mann, deceased, and devised to the children and widow of A. C. Mann who thereafter conveyed their interest therein to the grantor.
