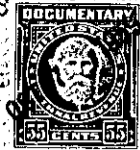

Know All Men by These Presents:

That I, WILLIAM R. TIMMONS, JR., in the State aforesaid, in consideration of the sum of THREE THOUSAND TWO HUNDRED FORTY-FIVE AND NO/100---DOLLARS, (\$3,245.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JEANETTE E. FOWLER, Her Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 123 of a subdivision known as McSwain Gardens, Section 2, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book LL at Page 137, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Old Spartanburg Road at the joint front corner of Lots 122 and 123 and running thence N 06-53 W 200 feet to a point at the joint rear corner of Lots 122 and 123; thence S 83-07 W 99.6 feet to a point on the Eastern side of Beaufort Street at the joint corner of Lots 123 and 124; thence with the Eastern side of Beaufort Street S 15-37 W 85.7 feet to a point; thence continuing with the Eastern side of Beaufort Street S 07-12 W 72.8 feet to a point; thence still continuing with the Eastern side of Beaufort Street S 06-53 E 35 feet to a point; thence following the curvature of the Northeastern intersection of Beaufort Street with Old Spartanburg Road (the chord of which is S 51-53 E 21.2 feet) to a point; thence with the Northern side of Old Spartanburg Road N 83-07 E 135 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1959 Taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and Her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
