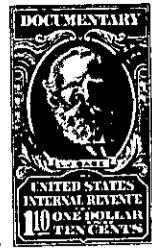

Know All Men by These Presents:

That I, J. Frank Williams, in the State aforesaid, in consideration of the sum of Nine Hundred & no/100 (\$900.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Henry C. Harding, his heirs and assigns: All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 22 of Western Hills, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book QQ, pages 98 and 99, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on El Paso Drive at joint front corner of Lots Nos. 21 and 22, and running thence with the line of said lots S. 12-21 E., 125.6 feet; thence S. 65-21 W., 153.5 feet; thence N. 12-21 W., 156.6 feet to an iron pin on El Paso Drive; thence with El Paso Drive N. 77-39 E., 150 feet to the point of beginning.

This conveyance is made subject to the recorded restrictions applicable to Western Hills and the easements and rights of way shown on said plat.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
