All that piece, parcel or lot of land situate on the east side of Corrinne Drive in the City of Greenville, South Carolina, and being known and designated as Lot No. 74, and the adjoining 60 feet of Lot No. 73, of Block "F", University Heights, as shown on a plat prepared by Piedmont Engineering Service, January 1949, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "BB"; at Page 21, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Corrinne Drive at the joint front corner of Lots 74 and 77, Block F, and running thence along the line of Lot No. 74, S. 56-37 E. 207.5 feet to an iron pin; thence S. 31-13 E. 160 feet to a point in the rear line of Lot 73; thence running along Lot 73, S. 56-37 W. 209 feet more or less to an iron pin on the northeast side of Corrinne Drive in the front line of Lot 73; thence along the northeast side of Corrinne Drive, N. 31-13 W. 160 feet to the beginning corner.
