B. G. Hunter, II and Joann Raines Hunter, their heirs and assigns forever:

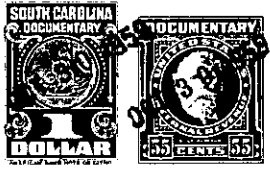
