ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South
Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot
Number 146 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office
for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds,
to wit:

BEGINNING at a point on the Northwestern side of Fairfield Drive at the joint front corner of Lots
