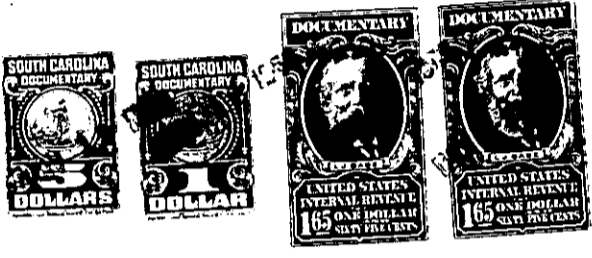
Know All Men by These Presents:

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 7 of Western Hills, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book QQ at Pages 98 and 99, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on El Paso Drive, at joint front corner of Lots Nos. 6 and 7, and running thence with the line of said lots, N. 50-17 E., 187.4 feet; thence N. 35-23 W., 85.2 feet; thence S. 50-17 W., 194.4 feet to an iron pin on El Paso Drive; thence with El Paso Drive, S. 39-43 E., 85 feet to the point of beginning.

The above described lot is conveyed subject to the recorded restrictions applicable to Western Hills and the easements as shown on said plat.
