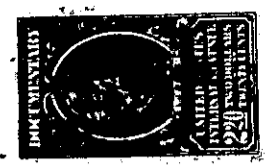

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Botany Woods Building & Sales Co., Inc., its successors and assigns forever:

All that lot of land lying on the eastern side of Arundel Road, in Chick Springs Township, near the City of Greenville, Greenville County, State of South Carolina, being shown as lot # 78 on plat of Botany Woods, Sector 2, as shown on plat recorded in Plat Book QQ at Page 79, and according to said plat being more particularly described, as follows:

BEGINNING at an iron pin on the eastern side of Arundel Road, at front corner of lot # 77, and running thence with line of said lot S. 87-51 E. 180.1 feet to iron pin in rear line of lot # 68; thence with rear line of lots # 68, 67 and 66, N. 3-43 W. 175.8 feet to iron pin at rear corner of lot # 79; thence with line of said lot, S. 79-08 W. 180 feet to iron pin on the eastern side of Arundel Road; thence with the curve of the eastern side of said road the following: S. 7-43 E. 70 feet to a point, S. 0-54 W. 65 feet to the beginning corner.
