Know All Men by These Presents:

That I, Walter W. Goldsmith, in consideration of the sum of Eleven Hundred Forty (\$1140.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. W. Fore, his heirs and assigns forever:

ALL those pieces, parcels or lots of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as lots 59 and 60, Section B, Englewood Estates, as shown by a plat thereof dated November 1951, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "BB", at page 11, and having the following metes and bounds:

BEGINNING at an iron pin on the north side of Englewood Drive at joint front corners of lots 61 and 60 and running N. 87-30 W. 150 feet to an iron pin on Englewood Drive, joint front corners of lots 59 and 58; thence with the common line of lots 59 and 58 N. 2-30 E. 150 feet to an iron pin at joint rear corners of lots 58 and 59; thence with the rear line of lots 59 and 60 S. 87-30 E. 150 feet to an iron pin, joint rear corners of lots 60 and 61; thence with the common line of lots 61 and 60 S. 2-30 W. 150 feet to an iron pin on Englewood Drive, the point of beginning.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any Negro of person of African descent. No residence shall cost less than \$8,000.00; no residence shall be erected nearer than 50 feet to the front line; and no residence shall be erected on said lot unless it have 50 feet, or more, frontage. No outside toilets are permitted; sewage must be disposed of by approved septic tanks.

GRANTEE herein is to pay taxes for the year 1959.

This property is conveyed subject to any rights of way now existing.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

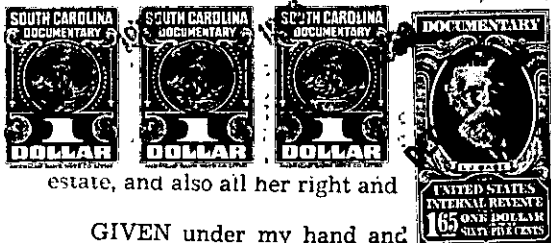
