to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said George M. Chaplin, his heirs and assigns:

All that piece, parcel or tract of land, situate, lying, and being on the Southwest side of Stevenson Lane, in Gantt Township, in Greenville County, South Carolina, being shown as lot No. 41 on plat of Dixie Farms, made by Dalton and Neves, Engineers, December 1939; recorded in the R. L. C. Office for Greenville County, South Carolina in Plat Book L, page 5, and having, according to said plat, the following metes and bounds to-wit:

Beginning at an iron pin on the Southwest side of Stevenson Lane at the joint front corner of lots 39 and 41, and running thence along the line of lot No. 39, S 18-36 E 249.7 feet to an iron pin; thence S 62-05 W 390 feet to an iron pin; thence N 75-13 W 235.7 feet to an iron pin; thence N 20-10 E 182.3 feet to an iron pin; thence N 60-53 E 41.9 feet to an iron pin in Stevenson Lane; thence with the curve of Stevenson Lane (the chord being S 80-33 E 73.5 feet) to an iron pin to the beginning corner.
