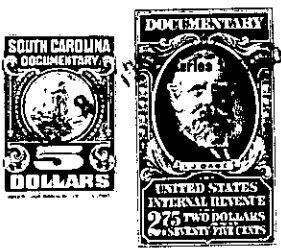
sum of Two Thousand Ninety and No/100 (\$2,090.00)-----dollars,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto RICHARD C. REYNOLDS and SARAH P. REYNOLDS:

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 9 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in January, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Roberta Drive, the joint front corner with Lot No. 8, and running thence along the Northern side of Roberta Drive S. 79-29 E. 100 feet to an iron pin; thence turning and running along the line with Lot No. 10 N. 10-31 E. 303.4 feet to an iron pin; thence N. 85-29 W. 100.55 feet to an iron pin; thence along the line of Lot No. 8 S. 10-31 W. 292.9 feet to an iron pin on Roberta Drive, the point of beginning.
