to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. W. Fore, his heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being known and designated as lots 401 and 402, Section D, in a subdivision known as Englewood Estates, as shown by a plat thereof, dated February 1955, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "BB", at page 177, and having the following metes and bounds:

BEGINNING at an iron pin on the southwest side of Evelyn Drive and running N. 36-20 W. 241.8 feet to an iron pin at the corner of Evelyn and Shasta Drive; thence running with Shasta Drive N. 85-0 W. 92.4 feet, more or less, to an iron pin on Shasta Drive at joint front corner of lots 402 and 403; thence with the common line of lots 403 and 402 S. 5-0 W. 185.0 feet to an iron pin at rear corners of lots 403 and 402; thence with the rear line of lot 402 S. 85-0 E. 81 feet to an iron pin at corners of lots 402 and 401; thence continuing with the line of lot 401 S. 85-0 E. 168.4 feet to an iron pin on Evelyn Drive, the point of beginning.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence shall cost less than \$8,500.00; no residence shall be erected nearer than 50 feet to the front line; and no residence shall be erected on said property unless lot has 50 feet, or more, frontage. No outside toilets are permitted; sewage must be disposed of by approved septic tanks.

This property is conveyed subject to any rights of way now existing.
