Know All Men by These Presents:

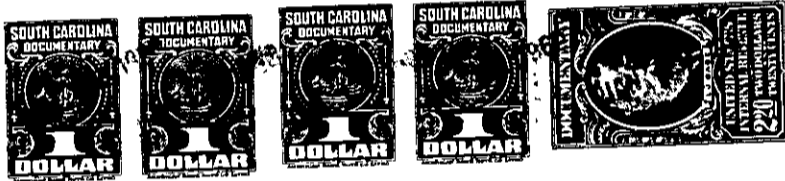

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said DAVID W. BALENTINE, his heirs and assigns forever:

ALL that certain piece, parcel and tract of land in Chick Springs Township, County and State aforesaid, known and designated as Lot No. Five (5) on a Plat of "Rosedale Sub-Division", prepared by C. O. Riddle, Registered Land Surveyor, in February, 1959, and recorded in the R.M.C. Office for Greenville County, said lot having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Rosemary Lane approximately 452 feet from the intersection of Rosemary Lane and Edwards Road and running thence along the joint lines of Lots Nos Four (4) and Five (5) N. 18-45 E., 143.5 feet to an iron pin; Thence S. 73-52 E., 105.5 feet to an iron pin at the joint rear corners of Lots Five (5) and Six (6); Thence S. 20-45 W., 151 feet to an iron pin on Rosemary Lane, the joint corner of Lots Five (5) and Six (6); Thence N. 70-25 W., along Rosemary Lane 100 feet to the point of beginning.

The above described lot is conveyed subject to those certain Protective Covenants recorded in Book 632 at Page 135 in the R.M.C. Office for Greenville County, and in addition thereto is conveyed subject to a drainage easement on the Northeast side of said lot.
