and Clara Burdett, Plaintiffs

on or about the 9th day of January in the year of
our Lord nineteen hundred and Sixty exhibited their
complaint in the County Court for the County aforesaid, against Edward Burdett, a
minor over the age of fourteen, Defendant

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to
be heard on the 18th day of January 19 60
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,
Master in and for the County aforesaid, to Charles E. Blakley and Ethel H. Blakley
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Preesents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree, upon receipt of \$6500.00
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Charles E. Blakley and Ethel H. Blakley

"All that piece, parcel or lot of land in Greenville County, Greenville
Township, State of South Carolina, being known and designated as Lot No.
5 on plat of property of Elizabeth Looper made by R. E. Dalton,
Engineer, December, 1924, said lot has a frontage of 50 feet on Gordon
Street and runs back in parallel line of a depth of 150 feet."

ALSO:
"All that piece, parcel or lot of land in Greenville Township, Greenville
County, State of South Carolina known and designated as Lot No. 6 accord-
ing to a plat made by R. E. Dalton, December, 1924 of the land of Eliza
T. Looper, having the following metes and bounds, to-wit:
BEGINNING on the north side of Gordon Street, at the corner of Lot No. 7
200 feet east from the corner of Washington Avenue and Gordon Street,
thence running with the line of Lot No. 7 N. 22 W. 150 feet to a pin on
the line of Lot No. 19; thence with the line of Lot No. 19 N. 71-20 E.
50 feet to the corner of lot No. 5; thence with the line of lot No. 5
S. 22 E. 150 feet to the north side of Gordon Street; thence along the
line of Gordon Street S. 71-17 W. 50 feet to the beginning corner."
