ALL That certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, near the city limits of Greer, S. C. and being known and designated as Lot No. 32 on plat of Brookwood subdivision, prepared by B. B. Waters, Jr., Surveyor, October 14, 1958, and recorded in the Office of the R.M.C. for Greenville County in Plat Book QQ, Page 21, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the East side of Brookwood Drive, joint front corner of Lots 32 and 33, and running thence along the joint line of said lots, S. 87-27 E. 366.6 feet to a point, joint rear corner of Lots 32 and 33; thence N. 2-44 E. 74.8 feet to an iron pin; thence N. 2-48 E. 25 feet to an iron pin, joint rear corner of Lots 32 and 31; thence along the joint line of said lots, N. 87-27 W. 367 feet to an iron pin on the East side of Brookwood Drive, joint front corner of Lots 32 and 31; thence along the East side of Brookwood Drive, S. 2-33 W. 100 feet to the point of beginning.

This property is subject to easements and protective covenants applicable to all numbered lots in Brookwood dated October 20, 1958 and recorded in the Office of the R.M.C. for Greenville County in Deed Book 609, Page 49.
